

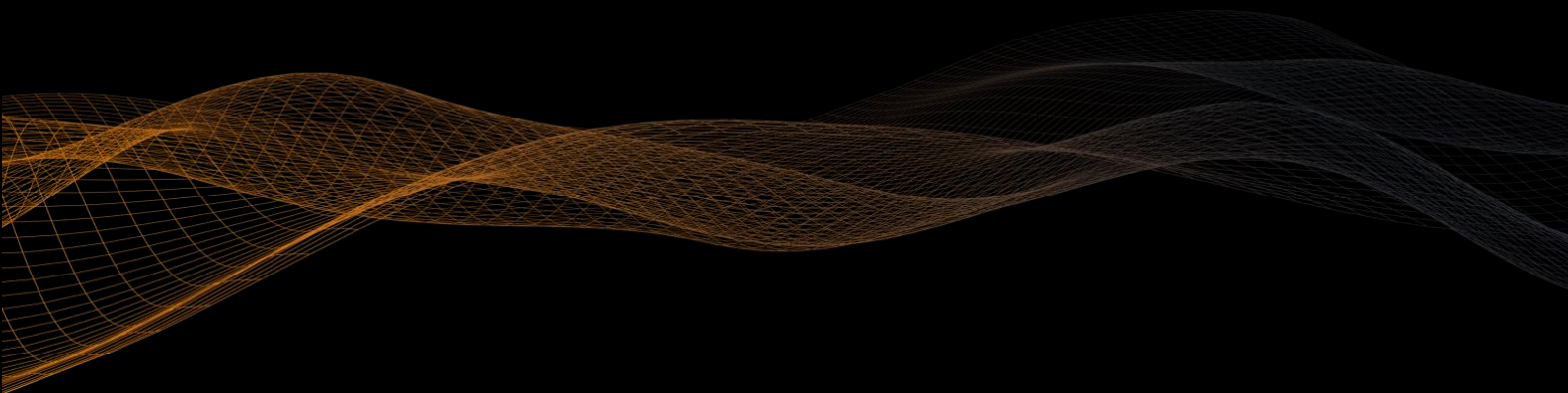

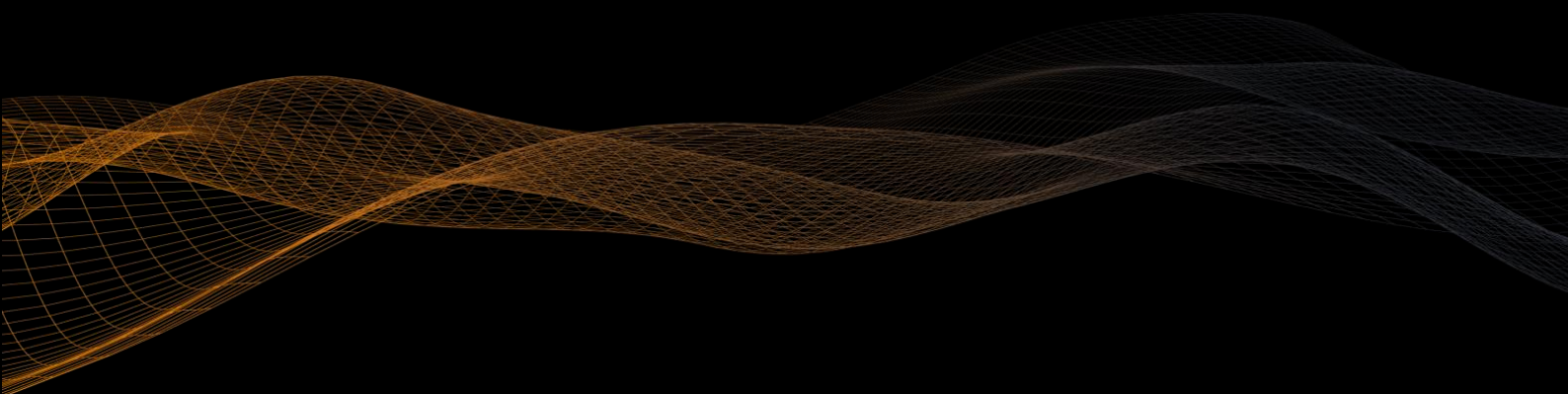

## Abstract

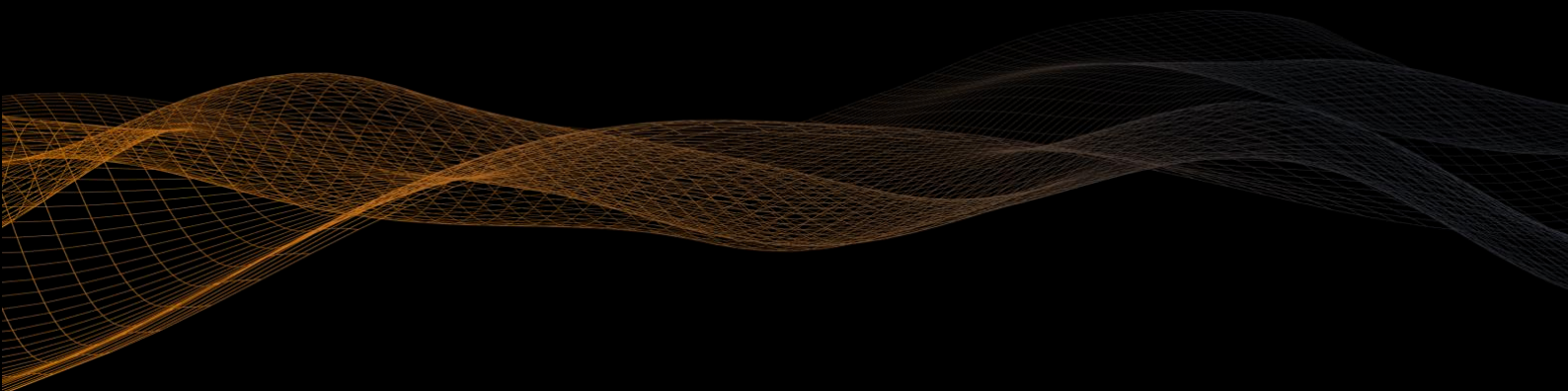

# Tokenomics

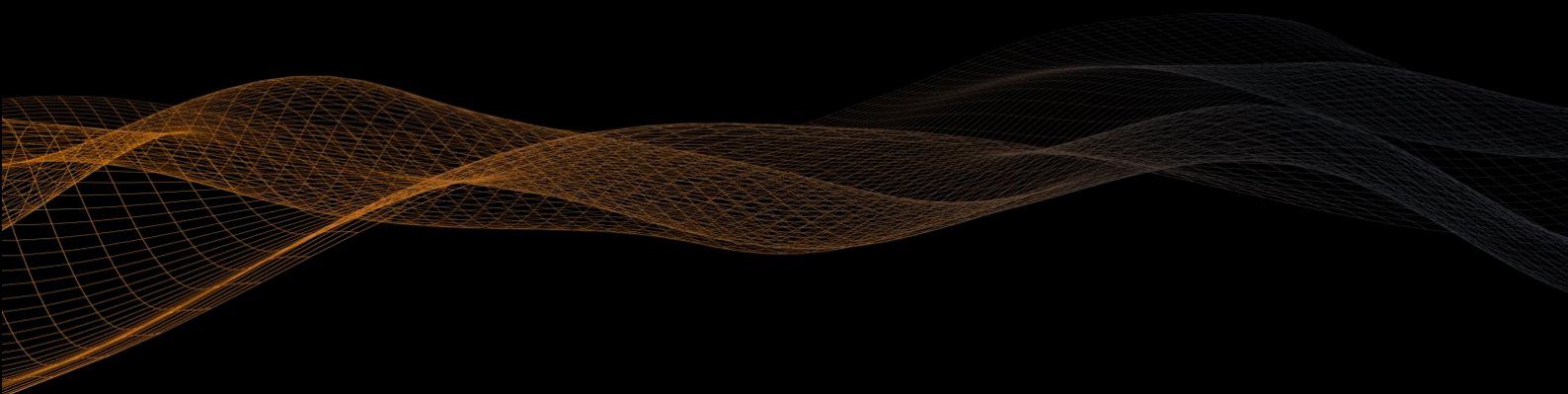
## Total Supply: 300 Million TVR Tokens

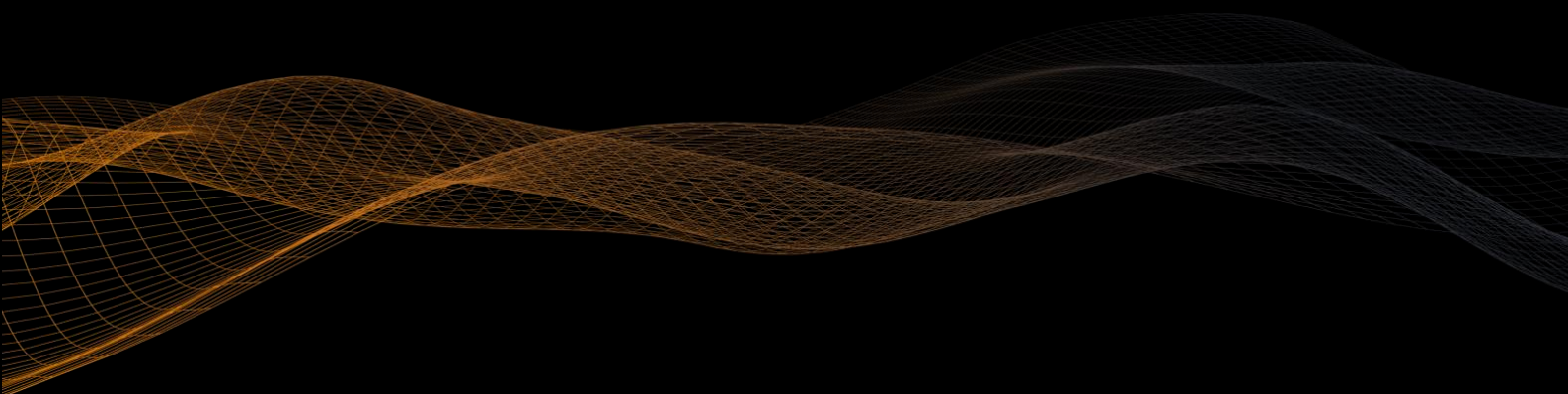

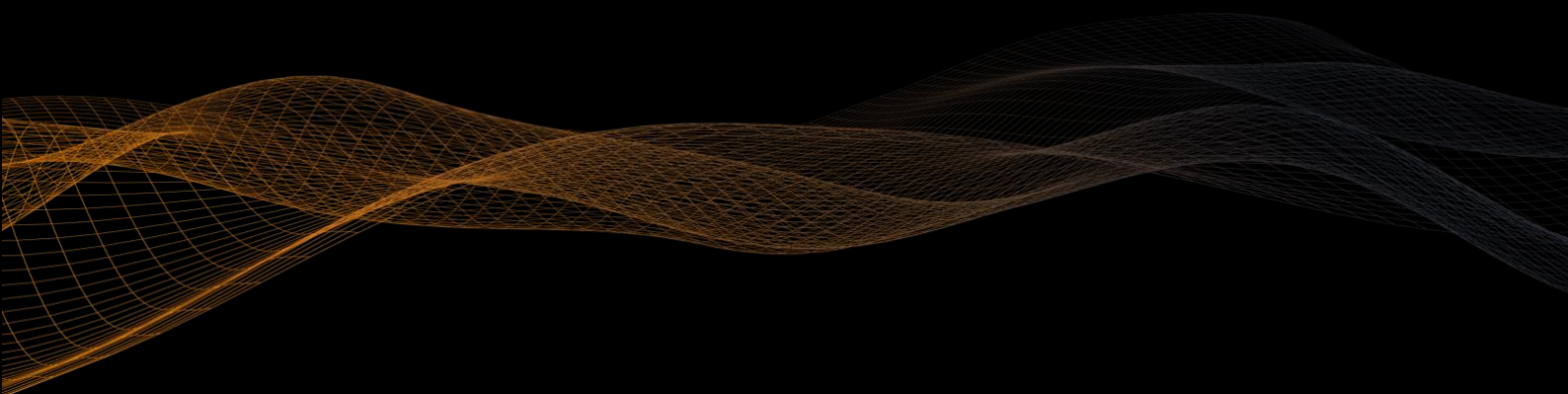
## Roadmap
